In February 2020 Professor Pierre de Gioia Carabellese has been appointed Professor (chair, tenure) of Business Law and Regulation at Edith Cowan University, Perth, Australia, School of Business and Law. Prior to this Professor Pierre de Gioia Carabellese had been full professor of law in England since 2017 (and fellow of Advance Higher Education), and is a specialist in banking and financial law and corporate law. Pierre has contributed to no fewer than 70 pieces of research in the area of banking law, financial law, contract law, employment law and business law regulation. He has recently submitted, for Routledge (London and New York), the second edition of "European Banking and Financial Law", a book written with Professor Matthias Haentjens, Leiden University, following the first edition published in 2015. In December 2019 Professor de Gioia Carabellese has published a monograph for Wolters Kluwer on "Resolution tools, bail-in and fundamental rights", while a second monograph (in Italian) has been



accepted for publication with Studium: this focuses on "Internal banking recapitalization: epistemology, physiology and pathology". In 2018 his chapter on "Securitisation and shadow banking" was published in a research book on shadow banking edited by Professor Chiu (UCL) and Professor MacNeil (Glasgow) e published by Edward Elgar.

Pierre has published in the main European and international law journals, such as the Maastricht Journal of European and Comparative Law, he sits on the editorial boards of various editorial journals and he is now responsible for the new series of Business Law, published by Studium. Professor de Gioia Carabellese has delivered keynote speeches in banking and corporate law in some of the main research centres in Europe, such as University College of London, King's College London and the University of Milan and .

After a successful spell in banking (e.g. the law department of Deutsche Bank, as Head of Corporate and Investment Banking) and international law firms (e.g. Baker & McKenzie), Pierre began his career in academia in 2007 as Tutor in Contract Law at the University of Edinburgh (Law School, under the Chair of Professor Hector Macqueen). In 2008 he was appointed Assistant Professor of Business Law at Heriot-Watt University (with promotion to grade 8 in 2010), in Edinburgh. In 2012 he progressed to an Associate Professorship in Business Law. Between 2010 and 2017 he acted as Director of the International Business Management Degree programme, during which time he secured partnerships with Cà Foscari Venice, Ludwig Maximilian University and Carlos III, among others. At Heriot-Watt University, with his teaching on business law, he was rewarded with three teaching Oscars, as the best lecturer of the University in 2012 (best feedback), best lecturer of the Business Management Department in 2014, and special Suave University Award in 2015. In April 2017 he was shortlisted as the best lecturer of the university in a further category. In 2017, after a very competitive public recruitment, Pierre was appointed full Professor of Law in England, where his successful period as Acting Head of the Law School of Huddersfield enabled him to gain membership of the CMI (Chartered Manager Institute). Pierre, who has been a Fellow of Advance Higher Education (York, England) since 2010 (as from 2017 as full Professor of Law), has been until now also a Professor (docente) of the Ph.D. School in Human Capital Formation and Employment Law at Bergamo.

Professor Dr de Gioia Carabellese has held a variety of visiting professorships in the last seven years, such as: salaried Visiting Professor of Employment Law at Ca' Foscari Venice, salaried Visiting Professor of Banking Law (University of Padova, the second oldest law school in the world), In Cagliari, in 2016 he was also salaried Visiting Scientist in Private Law. Pierre is a Solicitor and Notary Public in Edinburgh and an Avvocato in Rome, admitted to the highest courts. Since 2006 Pierre has been advising banks and multinational companies in the areas of contract law, banking law, financial law and corporate law, from his chambers in Edinburgh and Venice/Rome. With his knowledge transfer projects Pierre has secured grants for no less than euro 1,500,000.

He holds, amongst other awards, a Ph.D. in Banking and Financial Law from Siena, a Juris Doctor Summa cum Laude in Law (with final dissertation in banking law) and an LL.M. in European and International Trade Law (with distinction and dissertation supervisor Prof. Kapranos Huntley, on the concept of good faith in the Marine Insurance Act), a postgraduate qualification in Academic Practice (Heriot-Watt), and a Master's in Banking and Finance (Siena, 70/70, with final dissertation on takeovers).
